## **Campus Billing**

For Large Commercial customers that utilize multiple meters at primary voltage, they will be set up on a Campus Billing Rate. The primary and secondary meters will have the demand aggregated monthly and be billed the highest demand for that month. The energy component will be totaled for both meters per month. There will also be a capacity charge for the secondary feed charged monthly. It will be calculated by the previous year's peak demand multiplied by \$0.43.

## **Primary Metered Customers**

Primary Metered Customers are eligible to receive a 3% discount on energy charges.

## **Power Cost Adjustment (PCA)**

The PCA is reflected as a line item in the electric portion of your utility bill. The PCA is primarily due to the monthly fluctuation in the costs to generate and deliver the electricity used that are charged by the Utility's provider. These fluctuating costs are not included in the rates and are passed on to the customer. The utility does not earn additional revenue from the PCA.

An estimated portion of the fuel cost is included in the rates, however as the costs to produce and supply energy, primarily driven by the variability in the cost of fuel, the PCA ensures the full cost to provide electricity is recovered and available to pay for the power that is provided.

## **Franchise Fee**

A five percent franchise fee that was previously included in the electric rate now appears as a separate line item. This change was made to improve transparency and help residents better understand how utility costs are allocated.
